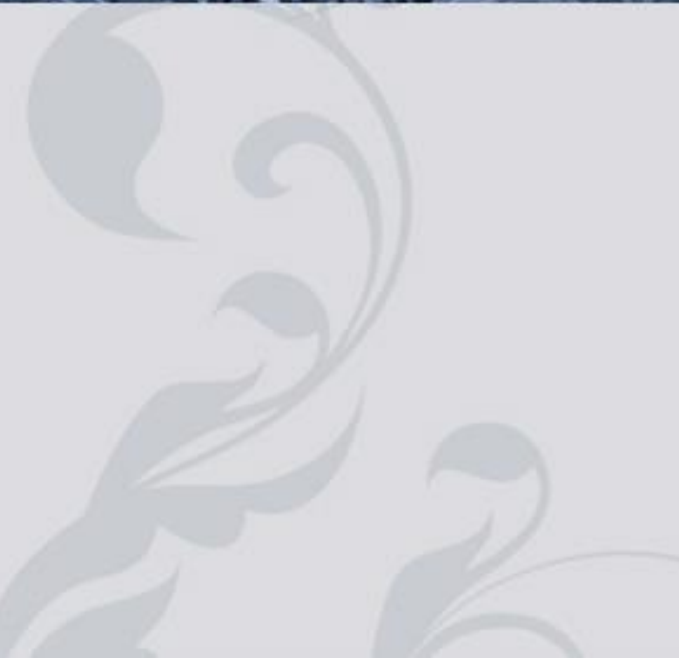

## General Policies

- 1.1. There may be legal or administrative reasons why a Domain Name may be Transferred between Registrants.
- 1.2. Domain Names may be transferred by the Registrant to any other third party meeting the Eligibility Requirements at any time.
2. Registrant Transfers of Domain Names where there are no Eligibility Requirements(.QA)
  - 2.1. Where a Domain Name that is not subject to any Eligibility Requirements is to be transferred, the transferee must make the Warranties as set out in the Registrant Agreement as described in Qatar Domains Registry Policy.
  - 2.2. The Transfer mechanism for Domain Names not subject to any Eligibility Requirements is as follows:
    - 2.2.1. ROUTEDGE must receive a written request for Transfer explaining the circumstances of the Transfer which is signed by the Registrant Contact (a request by telephone or email is not acceptable);
    - 2.2.2. ROUTEDGE must obtain confirmation of the request for Transfer from both the Registrant Contact and the authorized representative of the proposed new Registrant.
    - 2.2.3. The original Registrant is not entitled to be reimbursed by the Registrar for the unused portion of the Domain Name Licence Period.
    - 2.2.4. The new Registrant becomes the beneficiary of the remaining portion Domain Name Licence Period.
    - 2.2.5. The Registrar may charge an additional service charge to complete this transaction.
3. Registrant Transfers of Domain Names which are subject to Eligibility Requirements (All except .QA domain name)
  - 3.1. Requests for Registrant Transfer of a Domain Names which are subject to Eligibility Requirements must be validated against this Policy by the ROUTEDGE, and the Transfer should only occur if the request meets these requirements.
  - 3.2. Requests for Registrant Transfer of a Domain Name which are subject to Eligibility Requirements must be validated against this Policy by the ROUTEDGE, and the Transfer should only occur if the request meets these requirements.
  - 3.3. The intent of this policy is that Domain Names subject to Eligibility Requirements should not be Registered to be sold to another party for commercial gain.
  - 3.4. The Transfer of a Domain Names which are subject to Eligibility Requirements may occur under the following circumstances:
    - 3.4.1. when the Registrant sells all or part of the business entity that originally applied for the Domain Name and the Domain Name is listed in the deed of sale;
    - 3.4.2. if there is a transfer of intellectual property and the Transfer of the intellectual property includes the Domain Name;
    - 3.4.3. where a business entity becomes insolvent and the Domain Name is transferred to a liquidator, receiver, receiver manager, administrator or similar insolvency professional as a consequence;
    - 3.4.4. where there is a Transfer of the Domain Name between subsidiaries of the same entity;
    - 3.4.5. Where the Domain Name was registered by an agent on behalf of a client and there was an agreement that the Transfer would take place after the Registration, for example, where the agent is a marketing company, lawyer, or other professional services provider;
    - 3.4.6. where the Registrant's power of attorney is assigned to another entity, due to illness or death;
    - 3.4.7. where a competent arbitrator, tribunal, court or legislative body orders the Registrant to Transfer its Domain Name; or
    - 3.4.8. where the Registrant has entered into an agreement to Transfer its Domain Name to the proposed new Registrant in settlement of a dispute between the parties and the deed of settlement includes the Transfer of the Domain Name, (for example, where a trademark infringement dispute is settled out of court).
  - 3.5. Where the Registrant no longer meets the requirements to hold a Domain Name, the Domain Name must be Deleted from the Qatar Domains Registry Domain Name Registry System.
  - 3.6. In all cases, the Transfer of Domain Names which are subject to Eligibility Requirements will only be permitted where the proposed new Registrant meets the Eligibility Requirements of the Qatar Domains Registry Policy, and make the Warranties in the Registrant Agreement.
  - 3.7. Transfer mechanism for Domain Names which are subject to Eligibility Requirements:
    - 3.7.1. ROUTEDGE must receive a written request for Transfer that explains the circumstances of the Transfer and is signed by the Registrant Contact (a request by telephone or email is not acceptable).
    - 3.7.2. ROUTEDGE will obtain a declaration signed by the proposed new Registrant, or an authorised representative of the proposed Registrant, with any required relevant documents attached.
    - 3.7.3. ROUTEDGE will obtain confirmation of the request for Transfer from both the Registrant Contact and the proposed new Registrant, or an authorised representative of the proposed Registrant.
    - 3.7.4. The original Registrant is not entitled to be reimbursed by the Registrar for the unused portion of the Domain Name Licence Period.
    - 3.7.5. The new Registrant becomes the beneficiary of the remaining portion Domain Name Licence Period.
    - 3.7.6. ROUTEDGE may charge an additional service charge to complete this transaction.
4. The Qatar Domains Registry may investigate
  - 4.1. The Qatar Domains Registry may investigate
  - 4.1. The Qatar Domains Registry reserves the right to investigate any Domain Name Transfer.
  - 4.2. Where the Policy of the Qatar Domains Registry has been breached, the Domain Name may be deleted from the Qatar Domains Registry's Domain Name Registry System at which time it will become available for the next Applicant that meets the requirements of the Qatar Domains Registry Policy.
5. Theses Policy document has been prepared and published in order to represent the Qatar Domains Registry's Policy with regard to the administrative and technical management of the Qatar Domains Registry and the Qatar Domains Registry's Domain Name Registry
  - Domain Name Transfer Policy – Change of Registrant System. The Qatar Domains Registry may, at its sole discretion, review and/or amend this Policy at any time.

# Registrar - Registrant Agreement

## Registrar - Registrant Agreement

In order to complete the registration process you must read and agree to be bound by all terms and conditions herein.

We are an accredited registrar of QATAR DOMAINS REGISTRY for Country Code Top Level Domain (cTLDs) under an agreement between QATAR DOMAINS REGISTRY and ROUTEDGE. By agreeing to the terms and conditions set forth in this Agreement, you are also agreeing to be bound by the rules and regulations set forth by QATAR DOMAINS REGISTRY. ROUTEDGE may, in its sole discretion, elect to discontinue offering registrations or renewals with a previous reasonable notice with an option to transfer registrar services to any other competent registrars accredited by QATAR DOMAINS REGISTRY. Therefore, you acknowledge that we may modify the Agreement if necessary to comply with the QDR agreement or policies that may be adopted from time to time.

**Definition:**  
"REGISTRANT" refers to the individual or entity that wishes to register a domain name using the registration services provided by ROUTEDGE. "REGISTRAR" and "ROUTEDGE" refers to Domain Registrar accredited by QATAR DOMAINS REGISTRY through which registrant's application is processed. "Agreement" refers to this Domain Name Registration Agreement. "QDR" refers to "QATAR DOMAINS REGISTRY"

### 1. Application for a Domain Name Licence

- 1.1. The Applicant acknowledges and agrees that Applications for a Domain Name Licence shall be made to the QDR by the Applicants through ROUTEDGE, on behalf of the Applicant.
- 1.2. ROUTEDGE handover the completed documents after receiving payments to QDR will process applications for a Domain Name Licence.
- 1.3 A specialized well known Trade Mark Verification Agency will manage the trade marks verification process.
- 1.4 A 50 US Dollar Trade mark verification fee will apply for each sunrise application, this shall be paid to the Trademarks Verification Agency by the applicants
- 1.5 Verified Applications will be later uploaded after the sunrise period to the Registry System
- 1.6 The annual domain name registration fee will be applicable to trademarks verified and approved domain names to be registered after the sunrise period

- 1.3. The QDR in its sole discretion shall have the right to approve or reject any Application for a Domain Name Licence.

### 2. Registrant Warranties

The Registrant makes, and is taken to make, the following warranties to ROUTEDGE and to the QDR, when making an Application for a Domain Name Licence and when making an Application to renew the Registration of a Domain Name Licence:

- 2.1. Information provided in the Application for a Domain Name or in its Renewal (including all supporting documentation, if any) are true, complete and correct, and are not misleading in any way, and the Application is made in good faith;
- 2.2. The Registrant meets, and will continue to meet, the requirements of ROUTEDGE and all of the QDR Policies for the duration of the Domain Name Licence Period;
- 2.3. The Registrant is not Registering the Domain Name for an unlawful purpose, including but not limited to unfair competition, defamation, passing off or for the purpose of misleading any person, and will not, directly or indirectly, use the Domain Name for an unlawful purpose;
- 2.4. The Registrant will not, directly or indirectly, use the Domain Name in violation of any applicable laws or regulations;
- 2.5. The use or Registration of the Domain Name by Applicant does not or will not interfere with, nor infringe the right of any third party in the State of Qatar or in any jurisdiction with respect to trademark, service mark, trade name copyright or any other intellectual property right.
- 2.6. The Registrant is aware that even if the Application for a Domain Name is accepted, the Registrant's entitlement to Register the Domain Name may be challenged by others who claim to have an entitlement to the Domain Name; and
- 2.7. The Registrant is aware that ROUTEDGE with the permission of QDR can cancel the Domain Name Licence if any of the Warranties set out above is found to be untrue, incomplete, incorrect or misleading.

### 3. Consent to use Registrant Information

3.1. The Registrant grants to the ROUTEDGE the right to disclose to the QDR all information which is reasonably required by the QDR in order to Register the Domain Name in the Domain Name Registry System "Registrant Information".

3.2. The Registrant hereby grants to the ROUTEDGE and QDR:

- 3.2.1. the right to publicly disclose to third parties, all information relating to the Domain Name in accordance with QDR Policies and the laws of the State of Qatar; and
- 3.2.2. the right to publicly disclose and publish to third parties all information relating to the Domain Name to enable the QDR to maintain a public WHOIS Service

### 4. ROUTEDGE use of Registrant Information

4.1. The ROUTEDGE agrees that Registrant Information relating to any Registrant which it may obtain in the course of processing the Application for a Domain Name, or when maintaining any Domain Name Registration, shall only be used for the reasonable purposes of the operation of the QDR's Domain Name Registry System, or as a Registrant may consent in its agreement with ROUTEDGE. The ROUTEDGE shall not sell such information to any third parties.

4.2. The ROUTEDGE shall not disclose such information to any third parties except as required by the laws of the State of Qatar and the Policy of the QDR.

### 5. Maintenance of Registrant Information

- 5.1. Throughout the term of the Domain Name Licence Period, the Registrant must give notice to the QDR, through ROUTEDGE, of any change to the Registrant Information relating to the Domain Name Licence.
- 5.2. The Registrant accepts that its failure to comply with this requirement may lead to the cancellation of the Domain Name Licence.

### 6. Renewal of Domain Name Licence

6.1. The Registrant may apply to renew the Domain Name Licence, provided that it:

- 6.1.1. pays the applicable Renewal fees;
- 6.1.2. continues to meet the requirements of the QDR Policies; and
- 6.1.3. is within the period during which a Domain name may be renewed according to the QDR Policies.

6.2. The Registrant accepts that it is the Registrants responsibility to ensure that the Domain Name Licence is renewed before the expiry date.

### 7. QDR Policies

The Registrant must comply with all QDR Policies. In the event of any inconsistency between any QDR Policy and this Registrant Agreement then the QDR Policies will prevail to the extent of such inconsistency.

### 8. Revocation of Domain Name Licence

8.1. ROUTEDGE with the permission of QDR may, at its sole discretion, cancel the Registration of a Domain Name, or suspend a Domain Name Licence:

- 8.1.1. if the Registrant breaches any QDR Policies; or
- 8.1.2. in order to comply with a request of a law enforcement agency, or an order of a court, or under any applicable law of the State of Qatar, Government rule or requirement, or under any dispute resolution process; or
- 8.1.3. to protect the integrity and stability of the QDR Domain Name Registry System.

### 9. Limitation of Liabilities and Indemnity

9.1. QDR or ROUTEDGE including its directors, managers, employees, agents or contractors, will not be liable to the Registrant for any direct, indirect, consequential, special, punitive or exemplary losses or damages of any kind (including, without limitation, loss of use, loss of profit, loss or corruption of data, business interruption or indirect costs) suffered by the Registrant arising from, as a result of, or otherwise in connection with, any act or omission whatsoever of QDR, its directors, managers, employees, agents or contractors.

9.2. The Registrant agrees to indemnify, keep indemnified and hold ROUTEDGE or QDR, its directors, managers, employees, agents and contractors harmless from all and any claims or liabilities, arising from, as a result of, or otherwise in connection with, the Registrant's Registration or use of a Domain Name. Such claims shall include but are not limited to those based on trade mark infringement, copyright infringement, dilution, unfair competition, passing off, defamation or injury to reputation.

9.3. The QDR or ROUTEDGE provides no Warranty of any nature whatsoever with regard to any Domain Name, its Registration or its use.

9.4. The Registrant agrees and acknowledges that by Registering a Domain Name, the QDR or ROUTEDGE has not made any determination with respect to the purpose of the Domain Name Registration nor evaluate whether the Registration or use of a Domain Name may infringe upon any rights of a third party. As a consequence, the Registrant agrees that it shall not use the fact that the Domain Name has been registered through ROUTEDGE by QDR as a defence in any legal proceedings brought against the Registrant by any third party in connection with the Registrant's Registration and/or use of the Domain Name.

9.5. The Registrant agrees that Registration of a Domain Name shall not create any proprietary right for any Registrant, the ROUTEDGE or any other person. The Registrant shall represent that neither the registration of the Domain Name nor the manner in which it is directly or indirectly used, infringes neither the legal rights of any third party nor the laws of the State of Qatar.

9.6. The Registrant's intentional provision of incomplete and inaccurate information or its failure to promptly update information provided to the ROUTEDGE, or its failure to respond within fifteen (15) Calendar Days to enquiries by the ROUTEDGE concerning the accuracy of contact details associated with the Registrant's Domain Name Licence shall constitute a material breach of the Registrant Agreement and be a basis for cancellation of the Domain Name Licence.

9.7. Registrant acknowledge and agree that, in no event shall the Registrant pursue any claim against QDR, and the QDR shall not be liable for any loss or damage arising from or in connection with any breach by Registrant or ROUTEDGE of its obligations under any agreement between ROUTEDGE and the Registrant or this Agreement.

### 10. Dispute Resolution

10.1. ROUTEDGE shall not be a party to any dispute between a Registrant and third parties in connection with the Registrants' Domain Name Licence and/or use of a Domain Name.

10.2. By Registering a Domain Name, the Registrant shall be bound by the terms and conditions of the QDR's Dispute Resolution Policy and its associated Rules.

### 11. Change of Registrar

Registrant may change Registrar any time wishes to but annual registration fees may not be refunded.

### 12. Governing Law

This Agreement shall be governed by the laws of the State of Qatar.

### 13. Policy Definition and Review

This policy agreement has been prepared and published in order to represent the QDR's Policy with regard to the administrative and technical management of the QDR and the QDR's Domain Name Registry System. ROUTEDGE as per instructions from QDR may, at its sole discretion, update this Policy at any time.
